# **Access the Online Application**

Go to coto.org/apply now to begin your application.

# **Complete and Submit Your Application**

- Fill out the online application form.
- Pay the \$226 application fee.
- Submit your completed application.

### **Check Your Email for Next Steps**

- After submission, you'll receive an email from the College.
- The email will include a link to your personalized application checklist, and this is where you'll upload your required documents.

Important: Upload all documents through your checklist. Do not email documents unless specifically requested.



### **Upload Your Required Documents**

Please upload PDF files where possible:

- Proof of legal work authorization (Example: Canadian birth certificate, passport, citizenship card, permanent resident card, or valid work permit)
- Professional liability insurance (Copy of your insurance certificate)
- Vulnerable Sector (VS) check results (Note: Processing times vary by police service-check locally)



### When to Start Your Application

You may begin your application once you've completed your university program.

- Program completion confirmation is sent directly from your university to the College (Example: affidavit).
- Final transcript: After your convocation, contact your university and request that your official transcript be sent to the College via email at registration@coto.org.

# **Applying for a Provisional Certificate?**

- Upload proof of registration for the next CAOT NOTCE.
- Upload your Provisional Registration Supervision Agreement.

# **Applying for a General Certificate?**

- NOTCE results are required.
- CAOT will send your results directly to the College.



# Pay the Registration Fee

- Once all documents are approved, you'll receive an email with a link to pay your registration fee.
- See fee details: coto.org/fees



# **Receive Your Registration Confirmation**

 After payment, you'll receive a welcome email with your registration number and confirmation.

Note: You are not considered registered until you receive official confirmation and a registration number from the College.



### **Important Reminder**

You may not begin working\* as an OT until you are registered with the College and have received written confirmation and a registration number.

\*Working as an OT includes participating in orientation or training at the workplace.
